#### 5. STAFF REPORTS

Anne Conner- Says Joe Slack met with her on new plans for the library, we are moving forward with this project. The architect presented 4- 11x17 pages to go over new library in detail. Trivia night with be November 5<sup>th</sup> and the theme is GAMES.

Chief Waddington- He would like to promote fire prevention open house on Oct 13<sup>th</sup> from 6-8 pm with lots of activities for the kids.

Dufner has checked on the water rate for the cemetery and found the cemetery is already receiving the lowest rate possible and the high price has more to do with usage that month than the rate. Councilor Short asks Chuck if we can put string around to the different lots at Jefferson School to show where they are all located. Mayor Rowe suggests we use Lynn Kindred the Realtor to show us the boundary lines since we are paying him a percentage to sell the property.

#### 7. PUBLIC PARTICIPATION:

Alisha Brady 330 S. Folsom Court Coquille, OR 97423: Her neighbor dog attacked her, now she and her 9 year old autistic son are afraid to go out in their own yard. She went to the ER and now has an \$800 bill and police were called and cited the owner with "dog at large." She complained the dog tried to eat her in her own driveway and report shows nothing about this dog being vicious, or a name describing it in case this dog attacks again. She feels Coquille police didn't take the necessary steps to make sure her and her neighborhood are safe now. Chief Sanders explained we do have a broken system animal control system and we now have a better system in place should this ever happen again. Animal control was called but it was their day off. Councilor Heaton asks if they carry a noose to catch an out of control dog and Officer Hill replied they have one back at the station but it's not something they all have room to carry. Mayor Rowe thanks her for coming forward and helping us to put a better system in place for dog bites.

George Johnson- Asks where are we with the petition to not allow marijuana sales inside his neighborhood? Council and Mayor refer George to take this to the State level, as far as city laws they are not breaking any since it is legal now.
